PURCHASER'S WARRANTY

NON-COMMERCIAL USE – 2 YEARS; COMMERCIAL USE – 90 DAYS NON-TRANSFERABLE

The rights conferred by this warranty are in addition to other rights and remedies in respect of the product which you may have under the Trade Practices Act 1974 (Cth) and similar State and Territory laws.

Subject to the following Terms and Conditions, MTD PRODUCTS AUSTRALIA PTY LTD ACN 004 873 572 (MTD) will either repair or replace, at its option, the appropriate part or parts of this product if the product fails due to faulty materials or faulty manufacture.

Terms and conditions:

1. **Period:** this warranty is valid for notifications received by MTD or an authorised service dealer:

- (a) if the product has never been used in a business or other commercial setting within two years after you, the purchaser, purchased this product; and
- (b) otherwise, within 90 days after you, the purchaser, purchased this product.

New: This warranty applies only to goods purchased new by you from a retailer. The benefit of this warranty does not extend to any person other than you the purchaser and is non-transferable.

2. **Products purchased for re-sale:** This warranty does not apply to products purchased for the purpose of re-sale.

3. **Other exclusions:** This warranty does not apply where a part is not working due, or due in part, to normal wear and tear, misuse, abuse, excessive use, accident, neglect, improper maintenance or inappropriate storage conditions and does not apply if the product has been altered or modified or serviced by any person other than MTD or an authorised service dealer, and does not apply if the product has not been maintained and operated in accordance with the instructions supplied with the product.

4. **Cost of parts and labour only.** This warranty covers parts and labour and re-fitting of parts or re-assembly only, which will be provided free of charge. This warranty does not cover any consequential incidental or indirect damage loss costs or expenses. This warranty does not cover transport or transport insurance. It is your responsibility to arrange delivery of the product to use or an authorised service dealer and collection of the product from us or an authorised service dealer at your own cost and risk by arrangement with us or an authorised service dealer.

5. **Information required:** This warranty will not apply unless the information described on the top section of the opposite page is provided at the time of notifying the fault.

6. **Validity of claim:** MTD or an authorised service dealer may require you to arrange collection of the product or a part or parts without MTD repairing or replacing it or them where, after examining it or them, MTD or an authorised service dealer reasonably forms the view that the failure does not fall within this warranty.
