Battery replacement is required. Only adults should replace batteries. Required tool: Phillips screwdriver (not included).



Requires two AA batteries (included). Batteries included are for demonstration purposes only.

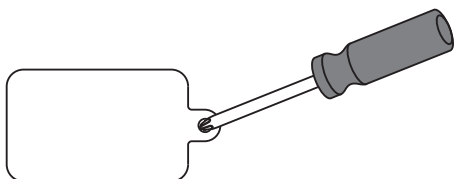


Slide the power/volume switch to ON with low volume ON with high volume or OFF .



Slide the mode switch to:

- 1 Sit & Play!** - press puppy for fun phrases, music, sound effects and blinking light.
- 2 Crawl After!** - press puppy for crawl and chase fun along revvin' sound effects, music, fun phrases and blinking light.



- When sounds or lights from this product become faint or stop, it's time for an adult to change the batteries.
 - Loosen the screw in the battery compartment door. Remove the batteries and dispose properly.
 - Insert two, new AA (LR6) **alkaline** batteries.
- Hint:** We recommend using **alkaline** batteries for longer battery life.
- Replace the battery compartment door and tighten the screw. Do not over-tighten.

- This toy moves best on firm carpet and smooth surfaces.
- Not recommended for use on loose dirt or wet surfaces. For indoor use only.
- Wipe the toy with a clean, damp cloth. Do not immerse. This toy has no consumer serviceable parts. Do not take apart.
- If this product begins to operate erratically, you may need to reset the electronics. Slide the power/volume switch off and back on.
