

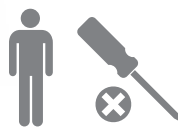

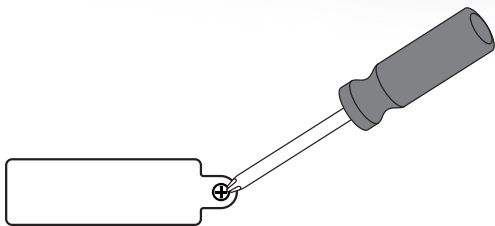

screwdriver (not included).



Requires one AAA battery
(included) for operation.
Battery included is for
demonstration purposes only.
For longer life,
use **alkaline** batteries.



- Locate the battery compartment door. Loosen the screw in the battery compartment door with a Phillips screwdriver. Remove the battery and properly dispose.
- Insert one, new AAA (LR03) **alkaline** battery.
- Replace the battery compartment door and tighten the screw. Do not over-tighten.

- When sounds/lights from this product become faint or stop, it's time for an adult to change the battery.
- If this product begins to operate erratically, you may need to reset the electronics. Remove the battery and reinstall it.
- Wipe the toy with a clean, damp cloth. Do not immerse. This toy has no consumer serviceable parts. Do not take apart.

Battery Safety Information
