

# Oil-Free Pancake Air Compressor Limited Lifetime Warranty



## 90- Day Satisfaction Guarantee

During the first 90 days after the date of purchase, if you are dissatisfied with the performance of this RIDGID® Air Compressor for any reason you may return the tool to the store from which it was purchased for a full refund or exchange. To receive a replacement tool you must present proof of purchase and return all original equipment packaged with the original product.

This Limited Warranty applies specifically to the  
RIDGID® 6 Gallon Portable Pancake Air Compressor.

## What is Covered?

The RIDGID® 6 Gallon Portable Pancake Air Compressor will be free from defects in materials and workmanship for its usable lifecycle, (the "Warranty Period").

If the RIDGID® 6 Gallon Portable Pancake Air Compressor fails to conform to the Limited Warranty during the Warranty Period, the Manufacturer will, at its sole discretion, repair, replace or offer free replacement parts for the RIDGID® 6 Gallon Portable Pancake Air Compressor. If the RIDGID® 6 Gallon Portable Pancake Air Compressor is no longer available, replacement parts may be provided or replacement may be made with a similar product of equal or greater value, at the Manufacturer's sole discretion. This is your sole and exclusive remedy for breach of this warranty. This Limited Warranty will not apply to any repaired product. This Limited Warranty is not transferable from the original purchaser to subsequent owners, and the Warranty Period will not be extended in duration or expanded in coverage for any such transfer.

## What is Not Covered?

This Limited Warranty does not cover damage to the RIDGID® 6 Gallon Portable Pancake Air Compressor on which the date code or other identifying markings have been removed or made illegible, damage caused by any modifications, alterations, tampering, or improper maintenance or repairs to the RIDGID® 6 Gallon Portable Pancake Air Compressor, damage resulting from handling, storage, installation, or use of the product which is improper, damage resulting from the addition of accessories not approved by the Manufacturer, damage caused by abuse, misuse, poor maintenance, or failure to maintain the product, as determined by the Manufacturer, in its discretion, damage resulting from normal wear and tear and Acts of God, and freight damage.

## How to Obtain Replacement Parts

The Manufacturer's warranty obligations are conditioned on the owner:

- (a) notifying by calling the number above during the Warranty Period and providing a description of the alleged failure with corresponding images;
- (b) reviewing and completing the Warranty Claim Form;
- (c) The Manufacturer will provide free replacement parts for the RIDGID® 6 Gallon Portable Pancake Air Compressor, which may be shipped to the owner's address.

However, the Manufacturer will have no warranty obligations with respect to a returned RIDGID® 6 Gallon Portable Pancake Air Compressor, including but not limited to costs of return shipping to owner, if the Manufacturer determines, in its sole discretion after examination of the returned RIDGID® 6 Gallon Portable Pancake Air Compressor, that this Limited Warranty does not apply to the RIDGID® 6 Gallon Portable Pancake Air Compressor for any of the reasons set forth in the What is Not Covered Section above.
